### **1. Purposes of processing - Legal basis of processing**

### **2. Methods of data processing**

Data will be processed using manual or automated tools. The personal data referred to you will be processed in accordance with the methods indicated by the law that provides, inter alia, that the data itself are:

- treated lawfully, correctly and transparently ("lawfulness, fairness and transparency");
- collected for specified, explicit and legitimate purposes, indicated above and subsequently treated in a way that is not incompatible with these purposes; ("Limitation of purpose");
- adequate, relevant and limited to what is necessary in relation to the purposes for which they are processed ('data minimization');
- exact and, if necessary, updated; all reasonable steps are taken to cancel or correct inaccurate data in relation to the purposes for which they are processed ('accuracy');
- kept in a form that allows identification of data subjects for a period of time not exceeding the achievement of the purposes for which they are processed, ie in relation to the duration of service and subsequent retention for tax purposes only and for a period not exceeding at 10 years. ("Conservation limitation");
